1. AS DEPT AWARE, SOUTH KOREA IS IN PROCESS OF FURNISHING  
LARGE QUANTITIES OF UNIFORMS FOR ETHIOPIAN MILITARY. UNIFORMS  
ARE CURRENTLY BEING DELIVERED BY AIR TO BOLE AIRPORT IN ADDIS.  
ACCORDING ROK AMBASSADOR, AIRLIFT BEING CARRIED OUT BY BOTH  
KOREAN AIRCRAFT AND CHARTERED AIRCRAFT OF AN AMERICAN COMPANY,  
KNOWN TO HIM AS "AIRLIFT." SEVERAL FLIGHTS HAVE ALREADY TAKEN  
PLACE.

2. AS RESULT RECENT EVENTS IN ETHIOPIA, JET FUEL IS IN IN-  
CREASINGLY SHORT SUPPLY AND KOREANS UNDERSTAND THAT BEGINNING  
JUNE 24, AIRCRAFT WILL BE FORCED TO REFUEL AT ADEN ENROUTE  
BACK TO SOUTH KOREA VIA COLOMBO. HITHERTO THEY HAD  
BEEN ABLE REFULE SUFFICIENTLY IN ADDIS TO REACH COLOMBO  
DIRECTLY. IT HIS UNDERSTANDING THIS DEVELOPMENT WILL  
AFFECT FIVE "AIRLIFT" FLIGHTS BEGINNING 0600 LOCAL
